President's Report

Barbara Klock (President)

- Moment for Mission
 - Shared the story of a recent visit to CCSA where she witnessed an inspiring situation between a student and teacher.

- Asking for feedback re: AW's review
- Read Resolution regarding designation of funds for additional classrooms. One amendment was made, adding the language "to secure additional space" after "3.5 million dollars."

<u>CCSA Foundation Update</u>, Chris Hanlon, Executive Director CCSA Foundation

- Cash balance for the Endowment Fund has increased to approximately \$3.5 million
- Endowment Committee will be planning small gatherings in the future to engage new and potential donors
- New Foundation staff member, Doreen Storey, will start June 6
- Office is currently working on annual end of year appeal letter
- Email featuring student Monet Lee will be sent out to all donors, please forward it on to any who might be interested in learning about the school
- Annual Fund is on track to reach goal of \$600,000 contribution to the school

 - All members will receive a survey on May 18 and will have until June 14 to complete it
- Board Leadership
 - Conversations with potential leaders have occurred and the Nom/Gov Committee will provide details soon

- Provided overview and update of the building expansion project
- Building inspection took place on May 9 and the report should be delivered the week of May 16

Finance Committee, Alice Turbiville (Committee Chair)

• S&P Rating

The review went very well and our rating was reaffirmed; all board members received a copy of the report

- Bond Repayment
 - Finance Committee is working with the Foundation Finance Committee, Charter Choices and US Bank to streamline processes around debt repayment for the bonds
- Overview of next year's budget
 - o Revenues
 - Enrollment: twenty-four additional Special Education students will add \$250,000
 - ESSER 2 and ARP ESSER funds will provide budget relieving income

- Review and explanation of Title 1, 2 and 4 funds
- o Expenditures
 - Staff salaries, including potential retention bonus for returning staff
 - Brief discussion regarding bonus versus additional salary expansion
 - Rising medical costs; health insurance went up by 12%
 - Site cost for modular lease
 - Strategic planning budget placeholder of \$250,000

School Report, Akosua Watts (Head of School/CEO)

- Provided overview of end of year calendar events
 - PSSA testing is currently happening for grades 3-8, science for students in grades 4 and 8
 - Select high school students will have Keystone Exams in select subjects
 - o Incoming K class has been enrolled and will come to the school on May 20 for assessments
 - Incoming K class will be invited to a five-week summer program
 - Currently identifying students who will be mandated to attend the summer program
 - There was a brief discussion regarding the effect of nearly two years of virtual learning; messaging will begin this summer to emphasize expectations and rules for 2022-2023 school year
